

## INFORMATION CLAUSE

Dear Patient,

Pursuant to Art. 13 item 1 and 2 of the Regulation (EU) of the European Parliament and the Council No. 2016/679 of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) hereinafter referred to as 'GDPR', we inform you that:

1. The Data Controller of your personal data is Dr. Antoni Jurasz University Hospital No 1 established in Bydgoszcz (85-094) at ul. Marii Skłodowskiej - Curie 9. You can contact it in the following way - by post: at ul. Marii Skłodowskiej - Curie 9, 85-094 Bydgoszcz, by phone: 52 585 48 80 or by e-mail: sekretariat@jurasza.pl.
2. In all issues related to your personal data, please contact the Data Protection Officer or their deputy in the following way - by post at the Controller's address with a mention 'JOD' or by e-mail at: iod@jurasza.pl.
3. Your personal data will be processed in connection with the provision of health services process, including keeping the medical records, as well as in order to ensure health care, manage systems and health care services and health prevention.
4. Processing of personal data that you provided is carried out on the basis of:
  - Art. 6 item 1 point c of the GDPR in terms of medical activity, including also keeping medical records (in connection with provision of the Act on medical activity and the Act on patient's rights and the Patient's Rights Ombudsman)
  - Art. 6 item 1 point d of the GDPR to the extent that is necessary for protection of vital interests of the patient
  - Art. 9 item 2 point c and h of the GDPR to the extent in which the data processed include the data of particular categories (among others the data on health condition).
5. The data recipients of your personal data will be entities entitled to process these data on the basis of the legislation and entities that process personal data on behalf of the controller on behalf of concluded contracts (service providers in the area of among others audit, shipping and transport services, maintenance of medical devices).
6. The period of storage of your personal data in medical records drawn up in paper form is defined in the Act on the patient's rights and the Patient's Rights Ombudsman (detailed medical records storage periods are listed at [www.jurasza.pl](http://www.jurasza.pl) in 'Poradnik Pacjenta' [*The Patient's Guide*] tab).
7. You have the right to request from the Data Controller to access your personal data, to rectify, to object, to remove the data or to have the processing of the data restricted, to withdraw your consent or the right of portability of the data.
8. If you consider that processing of your personal data breach provisions of the GDPR, you have the right to lodge a complaint to the President of the Office for the Personal Data Protection.
9. Provision of the data is voluntary, however failure to provide them will hinder provision of medical services.
